Release of Liability

In exchange for participation in summer camp activities operated by Ohio Valley Region CSB (OVRCSB), at the facilities of Stony Glen Camp (SGC) [an independent entity], of 5300 West Loveland Rd., Madison, Ohio, 44057 and/or use of the property, facilities and services of the aforementioned entities, I agree for myself and (if applicable) for the members of my family, to the following:

1. I have read and approved the information concerning camp. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by OVRCSB & SGC, or the employees, representatives or agents of OVRCSB & SGC.
2. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge OVRCSB & SGC for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of OVRCSB & SGC, whether caused by the fault of myself, my family, OVRCSB & SGC or other third parties.
3. I understand that in case of injury the participants medical insurance is primary and OVRCSB & SGC insurance is excess.
4. I agree to indemnify and defend OVRCSB & SGC against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the facilities of OVRCSB & SGC.
5. I agree to pay for all damages to the facilities of OVRCSB & SGC caused by my or my family's negligent, reckless, or willful actions.
6. Ohio Brigade Camp reserves the right to search campers' personal belongings if possession of banned or illegal substances/items are suspected.
7. I consent to the participation of _____ (adult or minor camper) in summer camp activities, and agree on behalf of myself or the above minor to all of the terms and conditions of this Agreement. By signing this Release of Liability, I represent that I have legal authority over and custody of the camper.
8. I also agree that any dispute that arises from this contract will be resolved solely through the Christian Legal Society. Any legal or equitable claim that may arise from participation in the above shall be resolved under Ohio law.
9. We understand that images of campers may be included in promotional material (camp brochure, website, video presentation) for Ohio Valley Region CSB Ministries. We further understand that NO camper names, phone numbers, addresses, names of family members or names of friends will appear in any promotional material. We grant permission to include my or my son's or daughter's picture in the publishing of promotional material as described.

I HAVE READ THIS DOCUMENT AND UNDERSTAND IT. I FURTHER UNDERSTAND THAT BY SIGNING THIS RELEASE, I VOLUNTARILY SURRENDER CERTAIN LEGAL RIGHTS.
